The railways metaphor





Who can propose a bill?




Who can stop or delay a bill?

Ireland

government control

- most plenary time is reserved for the government
- business committee sets the order of business on a weekly basis but it is the Government Chief Whip that decides on the content

Portugal/Italy

 the President of the Assembly sets the order of business after consulting with the conference of leaders

Ireland

government control

 arranged with the Committee Clerk through the Ministers Office (sponsoring Minister will be an ex officio member of the Committee while they consider the bill)

Portugal/Italy

 set by the parliamentary committee or by its chairman, after consulting the parliamentary group representatives on the committee (taking into consideration the plenary schedule)

How may possible obstruction in the plenary be curtailed?

Ireland and 'guillotine' motions

- they can be initiated by the government
- if successfully voted, debate is ended with one closure question, all Government amendments are deemed agreed and all opposition amendments rejected

Portugal and the emergency procedure

- It can be initiated by any Member of the Assembly of the Republic, any parliamentary group, the Government
- If successfully voted, it shortens the discussion to 5 days in committees and 2 for the final draft in the plenary

Conclusion



- Some prioritization is necessary to avoid logjams in the plenary ("arrival station")
- Rules to coordinate access to the plenary are necessary
- How time is managed should reflect the culture and broader institutional setting of the country
